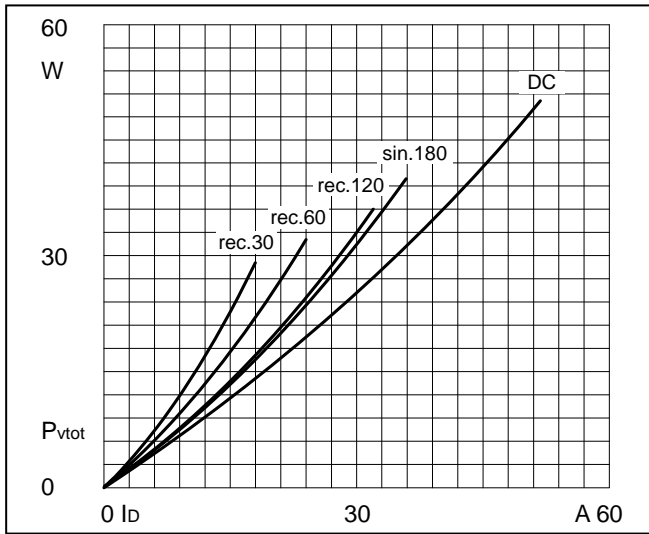

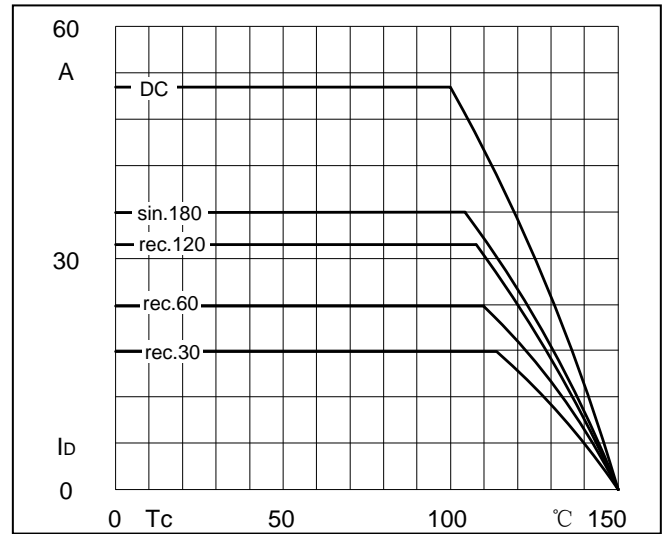

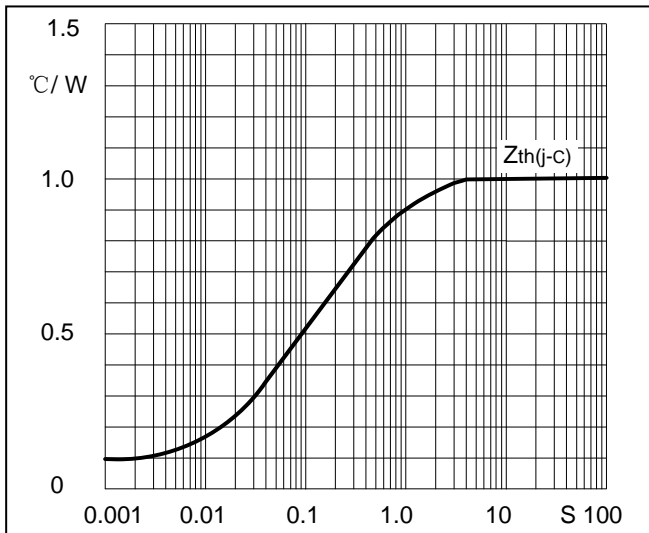

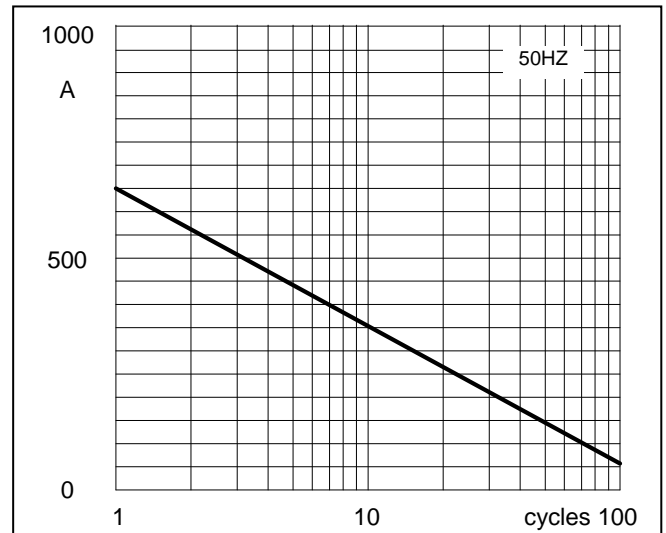
**Fig1. Power dissipation**



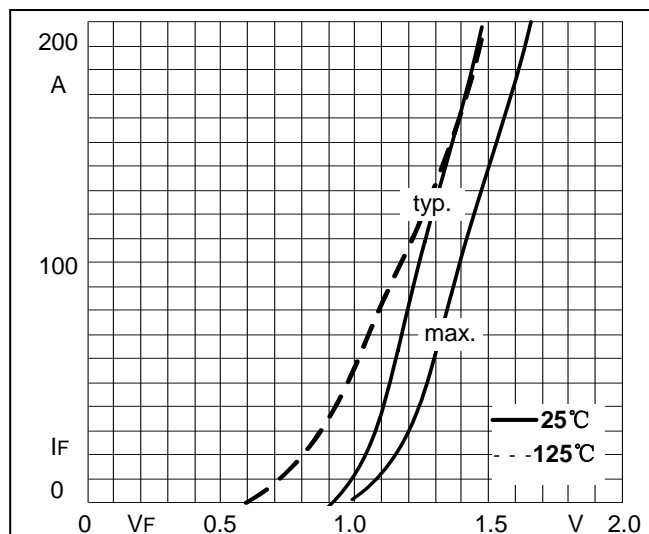
**Fig2. Forward Current Derating Curve**
